DIRECTIONS TO THE PIEDMONT BIRD HUNTERS CLUB

GENERAL DIRECTIONS: The Piedmont Bird Hunters Club is located just a few miles from the city of Monroe, North Carolina (off NC 74), which is located twenty miles southeast of Charlotte, North Carolina.

Take I-485 to exit 51 (US Hwy 74). Take U.S. highway 74-east into Monroe for approximately 12.6 miles. Turn left onto Morgan Mill Road. (N.C. 200 north). Look for Quincy's Steak House, this is where you want to turn left on to Morgan Mill Road.

(If you are coming up US Hwy 74 from Rockingham, you will be turning right at Quincy's onto Morgan Mill Road, NC-200, then follow directions below).

Follow Morgan Mill Road for 1 mile until you see a bear right sign, this will be Olive Branch Road; bear right onto Olive Branch Road. Follow Olive Branch Road for 0.7 miles until you see another bear right, this will be Helm's Pond Road, bear right onto Helm's Pond Road. Continue on Helm's Pond Road for 0.2 miles and turn right onto Farmwood Drive. Proceed on Farmwood Drive for 0.5 miles and keep your eyes open for the dirt road entrance to the grounds on the right.
