

New Agility Trials

The VCC is pursuing an endeavor to have an Agility Trial with the Greater Columbia Obedience Club (GCOC). The site is the South Congaree Horse Arena, where the VCC had their "A" Match in April 2011. The VCC Board has approved going forward, and we are waiting for GCOC's Board to answer a few questions, and approve on their end. If all is favorable, we will proceed this coming April 2-5, 2015.

The GCOC is already on the calendar with a three-day trial on April 3 -5. There would be one additional day added, and the VCC would have two of the four days as our trial, with the other two days remaining the GCOC's.

This is an awesome opportunity for our club. We will have the benefit of going in with a club that has an established date that people have on their calendar. We will have the benefit of working with people who can mentor us, and help teach us about running a trial. And we will be partnering with a club that already has all the equipment.

This is a *total* joint venture and our club's obligations would be to provide club members to work all four days of the trials, plus the Wednesday setup (which is half a day). Our committee members (Trial Chair, Hospitality, Worker Coordinator, etc.) would work together with GCOC's committee members. On

the two days of the VCC trials, we *must* have five club members on site at all times who will be designated as our Agility Trial Committee. These individuals can be any club member. For our hard work, we gain the needed experience to hold an Agility Trial. We will take all income from all four days and put it in a pot. We will then take all expenses for all four days (except our ribbons, toys etc.) and deduct that from the income, then split all the profit down the middle. Our club will pay a fee for two day's use of GCOC's equipment, which is only fair as they have \$15,000.00 in equipment.

Charlie's Story

In late May, we got a call from someone who had a four month old puppy. The couple had done a lot of 'research' into the breed, and purchased the dog from a hobby breeder when he was about six weeks of age. The man said that the puppy was now biting the couple's toddler, and had actually drawn blood. They had tried all manner of training to no avail. Concerned for the welfare of their child, they regretfully decided to give the dog up. So he said.

We were pretty confident that a puppy this young was not an aggressive dog. Because this was just a few days before our show at Fletcher, when many club members would be in attendance who could help evaluate, we were in a hurry to get this pup. He was in eastern North Carolina, where Daniel Martin had gone to school, so Daniel's best friend there picked up the pup at its home. Daniel drove to meet him for the hand-off and the trip to Fletcher. The consensus of all who spent those few days with Charlie was that this was a good puppy that had just been in the wrong setting. We lined up a foster home - Terri Smith and her family - who were known to the VCC as they had adopted another Vizsla rescue. The Smiths adopted Charlie, and couldn't be happier with the latest addition to their family. Here are some of the messages Terri sent us, as Charlie was settling into life with the family:

May 30: Wanted to update you on the new pup, the boys call him Charlie. Please feel free to forward this to the previous owners. We want them to know how much joy and fun he is bringing to our family.

We brought him home on Saturday, May 24. Our dachshund quickly let him know that she is the Queen of the house, and now they go nose to nose and she will wag her tail. But, when he gets rowdy, she lets him know! Our other dog Rainey, another V rescue about 4 yrs old, is VERY sweet and mild mannered, and has tolerated the new pup jumping and chewing on him. Charlie follows him everywhere and is LOST when Rainey goes outside without him.

On Sunday, we got up around 6:30 (he slept quietly all night), and started the day by taking Charlie for a walk. By 9:00 pm, Charlie had not laid down except for a 20 minute time in his kennel in the morning, and another 45 minutes in kennel while I cooked. I had never seen a dog that at some point during the day did not sleep - ANY! I was then worried that we would not be able to meet his energy needs.

Monday brought a completely different dog. I think he

was exhausted from Sunday. He played and slept like a "normal" dog. So far, I have seen NO bad habits (unless you include getting the toilet paper roll! LOL).

A few days later: Charlie is doing GREAT!! He is learning the ways of the house, and like the children, he REALLY listens when Dad speaks! LOL!! Why is that??!! Even though he is a puppy, he is gentle and calm, we can lean down or get on the floor and he doesn't go crazy all over you, or if he is really excited you can quickly calm him down.

June 6: Keith and I agree, we definitely want to keep Charlie! He is so smart and learning every day!! We are working, and he is doing great, on "FIND" the ball, rope, monkey and duck. Also, there is some tall monkey grass near our home. He loves for me to hide the ball in it and he finds it with his nose, which is not an easy task, but he doesn't give up.

Funnies.....he came out from the edge of the woods the other day with about a 4 foot long snake skin....he was proud! For some reason the door to his bed was not all the way closed this morning and at 5 am, which is about the time he can't hold it anymore, he worked his way out of the bed. We don't allow the dogs upstairs because the stairs are wooden and our smaller dogs were always afraid to go back down, and with 3 boys and stuff on the floor all the time.....Well, Charlie quietly was looking for us, came up the stairs, and I awoke just hearing something walking around our room! Scared me to death! He was so excited when he realized he had found us!

Anyway, yes, we all love him, though the boys are learning how much work a puppy is and 'Why, when you let him out, does he whine to come back in?' Those V's do not like to go out by themselves.

And Terri's final update:

Charlie has adjusted very well. We live near the lake and Clemson University where there is lots of land to run and chase animals. (Terri's) Mom also has a Vizsla puppy the same age, and they have play time almost every day.

Charlie is very inquisitive and is by your side a majority of the time....observing. He is very focused when it comes to chasing a ball or Frisbee and is doing well with obedience. He will be attending a hunt field training soon, and we plan to try Rally obedience. With two older boys still at home, and all their friends, Charlie receives lots of love and attention. He has been a fantastic addition to the household!




