## FUTURITY COMPETITION

### Eligibility

For a Vizsla Futurity puppy to be eligible to compete in the 2021 Futurity, it must meet all the following requirements:

1. Be from an eligible litter which was properly and timely nominated
2. Be individually nominated before it reached the age of four months

Copies of all pertinent information and correspondence regarding the nomination (including proof of all payments of nomination fees), ownership and nomination acceptance of the Futurity puppy must be available to the Futurity/Maturity Administrator in case of any errors, protests, or conflicts. Failure to do so could result in the Vizsla in question being disqualified from competition due to lack of proof of eligibility. The F/M Committee (FMC) will be responsible to rule on any protest or conflict regarding an entry to the Futurity/Maturity based upon the evidence and/or documentation at hand. The FMC's ruling will be final without further appeal or protest.

## MATURITY COMPETITION

### Eligibility:

For a Vizsla to be eligible to compete in the 2021 Maturity Division, it must meet the following requirement:

1. Be previously nominated from a properly and timely nominated litter in 2018, 2019 OR 2020 for the F/M Event and the dog has now aged into the Maturity Division.
2. A Vizsla is eligible to compete in the Maturity Division One Time Only.

Copies of all pertinent information and correspondence regarding the nomination (including proof of all payments of nomination fees), ownership, and nomination acceptance of the Futurity puppy must be available to the Futurity/Maturity Administrator in case of any errors, protests or conflicts. The F/M Committee (FMC) will be responsible to rule on any protest or conflict regarding an entry to the Futurity/Maturity based upon the evidence and/or documentation at hand. The FMC's ruling will be final without further appeal or protest.

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
